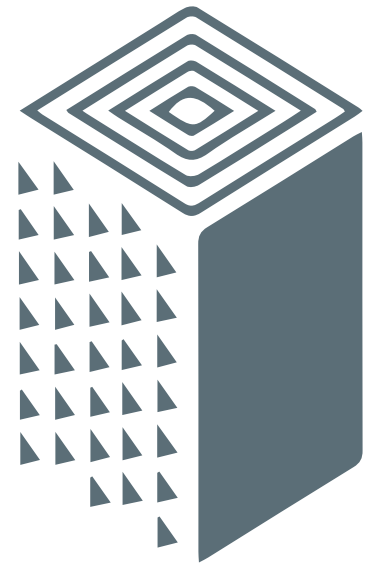

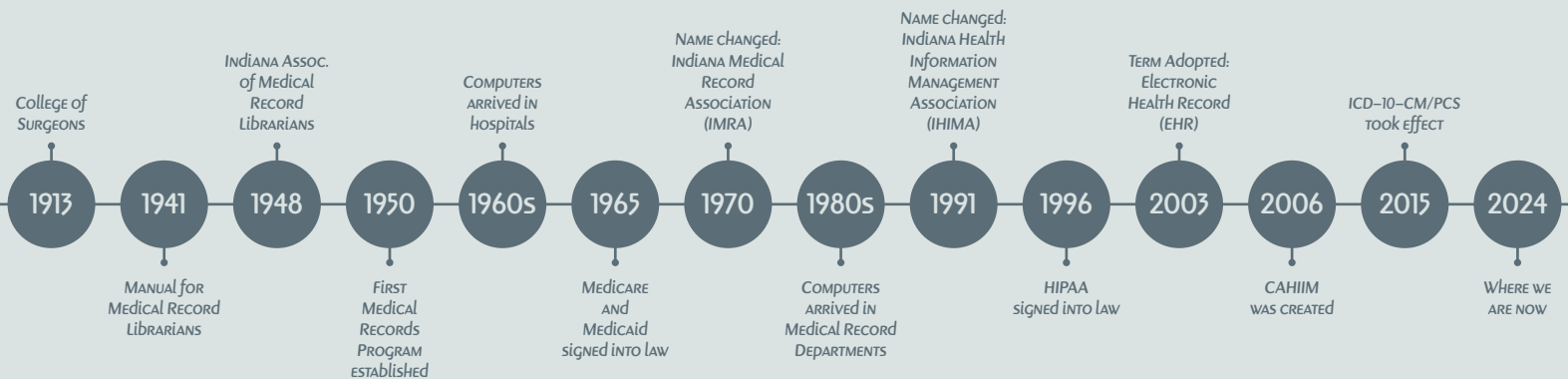
Coffee, tea, and a continental breakfast will be available in the Exhibit Hall on Monday morning.
