****The IHIMA 2020 Annual Meeting & Exhibit has been postponed.****

The IHIMA Executive Board has been carefully monitoring and discussing the coronavirus situation. After careful consideration, the Board has made the decision to postpone the 72nd IHIMA Annual Meeting & Exhibit scheduled for April 20th - 21st at Embassy Suites and Conference Center in Noblesville, IN.

Over the past few days, several things have happened which has brought us to the difficult decision to postpone this event:

- Confirmed cases of COVID-19 in Indiana
- A state of emergency has been declared by Governor Holcomb
- Employers are prohibiting employee travel and prohibiting employee's attendance at conferences
- Companies not being permitted to exhibit at conferences

The IHIMA Annual Meeting & Exhibit is being postponed to **September 28-29, 2020**. The conference will still be held at the Embassy Suites Hotel and Conference Center in Noblesville, IN.

All currently registered participants will have their registration roll to the new dates, if any registrant is unable to attend the conference in September, a full refund will be issued upon request. For those not yet signed up, registration will remain open for participants to sign up for the September date. If you must cancel, please complete this online [cancellation form](#).

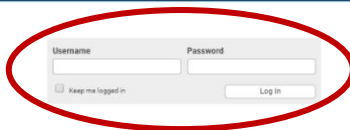

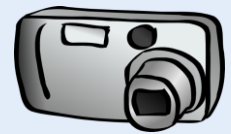

House of Delegate Update

Taken from AHIMA's State Leaders and House of Delegates Engage Community: [All Delegate Webinar, 3.11.2020](#)

On March 11, 2020, 105 delegates convened for their quarterly meeting.

The Speaker of the House gave an overview of the House of Delegates (HoD) Strategic Plan and strategic outcomes for 2020.

Goals include:

- Recognition of Delegates as the HIM profession's experts that should be looked upon as AHIMA's currency of experience. Initiatives developed from the HoD should be part of AHIMA's programmatic Book of Business to meet market needs.
- Delegates should be utilized as expert speakers to speak at the state level and share AHIMA's advocacy agenda.

Tactics include:

- Use the deliverables from the Professional Enhancement Campaign and disseminate to CSA and local leaders to spread the word about the HIM profession.
- Hold an orientation at the HoD level. Train them to be advocates on behalf of the profession and the association.
- Training to prepare Delegates to advocate so they can leverage their knowledge of the profession.

The HoD will be discussing these goals throughout the year and how we can achieve them.

The Speaker-elect of the House reviewed the Editorial changes to the [Ethical Standards for Clinical Documentation Improvement \(CDI\) Professionals \(2016\)](#). In 2019, a thought leadership roundtable of experts from the industry was convened. The group discussed the evolution and future direction of CDI, as well as meaningful roles that may exist in the future, and how AHIMA can support these roles.

A wording change was recommended by a roundtable of industry experts and validated by input from the CDI Summit, the CDI Practice Council, and comments solicited from AHIMA membership at large. The decision was to recommend AHIMA adopt and champion "clinical documentation **integrity**" as the three words comprising the acronym CDI. "Integrity" will replace "improvement" going forward.

This recommendation was submitted and approved by the AHIMA Board of Directors to upgrade the term CDI to reflect the profession's evolution. This was announced in the December 5th E-Alert, [AHIMA Membership Community on Engage](#), with the change taking effect **January 1**. Changes to the CDIP credential will be phased in gradually, as will references in materials related to the credential.

Because of this change, the desire is to update the Ethical Standards for Clinical Documentation Improvement Professionals to include the word Integrity in place of the word Improvement.

This was brought to the House Leadership Team for guidance on the next steps, because the Ethical Standards for CDIP are one of the documents that the HoD approved as specified in the AHIMA Bylaws. Changes to this document usually need a House vote. Yet, in this case, it is just replacement of a word based on the change of what CDI is being defined as. There were 2 options for the House Leadership Team to determine:

1. Agree to make this word replacement.
2. Submit change to the HoD for the 30-day comment period and then a vote to approve the change.

Via a survey conducted with the House Leadership Team, the results indicated that #1 was the choice.

The word Improvement will be changed to Integrity in the Ethical Standards for CDIP document and reposted on the BoK and the AHIMA Web site.

AHIMA staff reviewed some initiatives with the Delegates. Staff provided an overview of the Professional Enhancement Campaign. More information, resources and tools will be shared with Delegates soon about the Campaign, in order to help spread the word among CSAs. Staff also gave an update on the six 2020 Practice Councils' workplan and their new process for content development.

COVID-19: A Note from AHIMA's CEO

As the US monitors and prepares for the spread of the novel coronavirus (COVID-19), I wanted to let you know that AHIMA is here to support you. These are stressful times for many, but this is also a time when AHIMA members can make a difference. Our work has an impact on the quality of patient care, and our understanding of health information helps us tell the stories of our patients and the health of our communities.

To keep you up to date, we have resources available at [AHIMA.org/COVID19](https://www.ahima.org/COVID19). You'll find guidance for state associations planning annual meetings and the *Journal of AHIMA's* new report on a [tale of two hospitals fighting the virus](#) on the page, as well as the [latest Under the Dome column](#), which offers some background on COVID-19 and discusses new codes in development to track the virus.

The health and well-being of our members, speakers, and guests is our first priority. For that reason, last week AHIMA announced that we have cancelled the April [eHealthWeek Croatia](#) event. In addition, we announced yesterday that we are [cancelling our 2020 Advocacy Summit in Washington, DC](#). The AHIMA team is exploring how we can develop alternative ways for advocacy summit presenters to share their work that permits members to earn CEUs; stay tuned for more on this. Our [Virtual Hill Day](#) is still taking place on March 24.

We want everyone to be safe. To that end, please keep in mind the common-sense guidelines already being widely shared:

- Stay informed about COVID-19 with information from the [Centers for Disease Control and Prevention](#) and the [World Health Organization](#), as well as your local public health authorities.
- Wash your hands frequently with soap and water for at least 20 seconds, or use an alcohol-based hand sanitizer with at least 60-95 percent alcohol.
- Cover your mouth and nose when coughing and sneezing with a tissue, or use your upper sleeve, not your hands.
- Avoid touching your face.
- Stay home if you are unwell. If you have a fever, cough, and difficulty breathing, seek medical attention and call in advance.
- Follow the directions of your local health authorities.
