IHIMA Nominating Committee News

IHIMA Board Bullets

The IHIMA Board of Directors met on Friday, November 8th from 9:00 a.m. to 4:00 p.m. EST. The following includes the highlights of the meeting:

- 1) The Delegates reported on sessions attended at the House of Delegates meeting in Chicago, IL. The different sessions attended were: AHIMA bylaw changes, HIM champions developed an “elevator pitch”, environmental scanning, and best practices for engagement and communication. The new AHIMA Governance Task Force was also discussed. [Find more info here](#)
- 2) It was reported the AHIMA 2020 Advocacy Summit is now open to the entire AHIMA membership. It was recommended to register early because there is a maximum of 170 attendees.
- 3) The Legislative Committee reported there will be a video created again at this year’s IHIMA Day at the Statehouse. There are plans to have an educational webinar prior to the statehouse visit. Advocacy was encouraged then a committee chair presented at the CIHIMA meeting in October. The committee is continuing to work with the Indiana Hospital Association (IHA) regarding the Medical Record Charging Law. The committee is working on a proposal for Board review regarding updates to the Release of Information Guide/creating a Legal Portal. The committee plans to discuss patient directed requests from attorneys with Hall Render to determine if a draft letter can be created for HIM professionals to use.
- 4) The Professional Development/Annual Meeting Committee reported the Fall Conference was a success. Great feedback was received about the event. The committee also reported the 2020 Annual Meeting’s theme is “Olympics 2020 – Winning the Gold in Health Information”. The Annual Meeting is in the planning stages with agenda preparation, contacting speakers, and finalizing vendor booth/sponsorships.
- 5) The Nominating Committee is soliciting names for the 2020-2021 ballot. An email will go out to the membership soon. The ballot will include: President-Elect, Secretary, Treasurer, two (2) Delegates, and two (2) Nominating Committee members.
- 6) The Communications Committee reported a continued increase in social media engagement. The committee also reported that by promoting the NIHIMA and CIHIMA region’s fall events on social media, the regions had more attendees and saw new faces at their events.

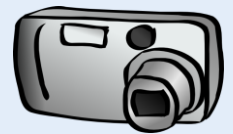

Here physicians, surgeons, and other professionals serving on the RUC, (the AMA's Specialty Society Relative Value Update Committee), explained the rationales for new or revised CPT codes that describe the resources required for physician services. Important information to know because correctly and compliantly reporting the procedures is vital for not just reimbursement purposes, but statistics and tracking. CPT codes can become deleted for low utilization—and if they are deleted, we have to report an unlisted service instead. We all know how hard those are to explain to payers! The conference was on the 7th floor Grand Ballroom of the Downtown Marriott. It was very comfortable with tables provided in order to spread out our new books they handed out (and new backpacks - "much better than last year, I heard.") and to take notes. The food and service were excellent. I can tell you my "wall of window" in my room on the 34th floor offered a beautiful and mesmerizing city view. Even saw some Christmas lights on the outside of some of the high rises. I'm going back closer to Christmas to see more!

AHIMA's Annual Advocacy Summit will take place March 23-24, 2020, in Washington, DC. This two-day event focuses on advocacy and public policy issues linked to AHIMA's mission and vision. Monday, March 23rd is AHIMA's Public Policy Institute where AHIMA members will hear from federal officials and other stakeholders in Washington, DC about ongoing public policy work impacting the HIM profession. Capitol Hill visits take place on Tuesday, March 24th where attendees have an opportunity to meet with their Members of Congress and staff and advocate on behalf of the HIM profession. Coding Corner - Fewer Codes for 2020 in ICD-10-PCS

There has been an increase in the number of possible codes in ICD-10-PCS every year since its implementation. With the Fiscal Year (FY) 2020 ICD-10-PCS code changes, effective October 1, 2019, the tides have turned. In the Medical and Surgical section, the annual update from the Centers for Medicare and Medicaid Services (CMS) has resulted in a net change of -1,382 codes. And despite the net increase of 80 codes in the Radiation Therapy section and hundreds of additions in other sections, altogether the FY 2020 changes to ICD-10-PCS resulted in 1,322 fewer codes.

Credential Recertification Reminder

A reminder for those with a recertification cycle ending December 31, 2019, the Standards for Recertification of the Commission on Certification for Health Informatics and Information Management (CCHIIM) require that you complete recertification requirements by your cycle end date. Requirements include:

- Payment of your recertification fee, and
- Recording of your continuing education units (CEUs), and
- If applicable, completion of annual self-reviews (for coding credentials only).

You're encouraged to log into your AHIMA CEU Center (<https://my.ahima.org>) now to review your CEUs and, if applicable, self-review progress. From your AHIMA CEU Center you can also verify your recertification cycle dates to determine if you are due to renew by the end of this year. As a reminder: There is no more need to "report" CEUs at the end of your cycle! On the last day of your recertification cycle, your account will automatically be reviewed and will roll over to your next cycle if all recertification requirements have been met.
